



WARRANTY and SUPPORT

Gobius – level indicator for tanks in stainless steel, steel, plastic, fibre glass and aluminum

The product you now have purchased is delivered in accordance with the conditions below. The product is developed by FM Marin (Feldt & Meiton Marin AB) in cooperation with various subcontractors. The product is sold and marketed by FM Marin, its distributors and retailers.

Warranty

1. The warranty for Gobius, the level indicator for tanks, is limited to one (1) years. Under this warranty FM Marin undertakes to, without extra charges, repair the defect or replace the product. All shipping costs in connection with repair or replacement of defective or damaged products shall be incurred by the customer. FM Marin's liability under this warranty is limited to defects, which appear within the following time limits; the buyer shall notify FM Marin without undue delay after the defect has appeared and in no case later than one (1) month after the defect has appeared. If the buyer fails to notice FM Marin about the defect within one (1) month after the defect has appeared the buyer loses his rights under this warranty.
2. This warranty is valid solely on the condition that the product is assembled in accordance with the attached instructions and that the product is registered on www.fmmarin.se, *Products*.
3. In order for the sensors to work properly, the tank wall thickness must be max. 3 mm for stainless steel, max. 3 mm for steel, max. 5 mm for aluminum, max. 8 mm for fibreglass and max. 12 mm for rotational moulding plastic (Polyethylen). This warranty will not be valid if the surface of the inside of the tank has an abnormal cover, which may have a negative impact on the sensors.
4. This warranty will not apply if the product has been modified in any way.
5. If the product is defect at delivery, it shall be immediately returned to FM Marin. Before returning the defective product, FM Marin shall be notified about the defect and the buyer will at that time be given a case code number in order to keep track of the issue until it is resolved.
6. If, within the warranty period, the product, malfunctions, the buyer is entitled to a replacement of the product free of charge. However, all transportation in connection with this replacement shall be at the buyer's risk and expense.
7. FM Marin is not liable for any damages if the user doesn't follow the product's level indication. The level is indicated by the illumination of the coloured lights on the panel
8. FM Marin shall not be liable for any damages or defects on the product caused by, e.g., power failure or any other unexpected circumstances beyond FM Marin's control that may have an influence on the function of this product.
9. In addition to the above, to complete this contract, the Swedish Köplagen, (1990:931) the Swedish Konsumentköplagen (1990:932) and the Swedish Distans- och Hemförsäljningslagen (2005:59) shall apply on this warranty



when applicable.
